Either for myself or I/we, the below signed parent(s)/legal guardian(s) of the individual or (list minor) _____ listed below, (hereinafter "minor"), hereby agree to assume full responsibility for the payment of all debts incurred by myself or the minor during my/his/her visit to the Nationals and to reimburse the Nationals for any damages suffered by Nationals due to acts of the minor during that visit.

I/we acknowledge that Nationals and/or US Spirit is not responsible for supervising the minor.
